To All Our Parents and Carers

The Governors and staff at Upton Junior School are continually looking at ways to develop and improve the school and we are proud of the welcoming and stimulating learning environment that we provide for our children. Many developments to date have greatly enhanced the school building and facilities, including our amazing Upton ship adventure playground, additional resources for the library and music room, outdoor equipment, play and sports equipment, enhanced wildlife garden and allotment area and we have a rolling programme to continue the development of our school and enhance learning even further.
